DOWNTOWN TRANSIT REDEVELOPMENT PROPOSAL

A great deal of public attention has been focused over the last two weeks on the new proposal to replace the underutilized Downtown Transit Center with a new development – a mixed-use high-rise building that came as a frontrunner among the four proposals considered. Milwaukee County has a great opportunity to create an iconic new building on our lakefront and a grand new entrance to our downtown – while creating more than 4,400 construction jobs, 200 permanent jobs and an increasing the overall tax base.

That is why it was disappointing to to previous see that, contrary discussions, the item involving the Downtown Transit Center redevelopment was not included on the agenda for the Economic and Community Development Committee meeting on July 16th particularly in light of the overwhelmingly positive response from local leaders and the broader community.

COMMISSION ON AGING APPOINTMENT

The Milwaukee County Board of Supervisors in June unanimously confirmed the appointment of Supervisor Taylor to the Milwaukee County Commission on Aging. The Commission on Aging is a governing and policy making arm of Milwaukee County's Department on Aging. Appointed Commissioners are responsible for developing and implementing a coordinated human service system of community-based services for Milwaukee County residents aged 60 and older.

Among the Commission's principal functions is assessing major aging issues and needs concerning individuals age 60 or older; reviewing the planning and service efforts of organizations and institutions in the county and its aging network; monitoring federal, state and local laws and regulations relating to care and treatment of older adults; and make recommendations on issues relating to older adults' well-being and functioning in order to enhance their ability to remain contributing members of society.

Throughout his years in public service, Supervisor Taylor has worked passionately on behalf of the aging population. His appointment to the County's Commission on Aging is a step further in that direction to ensure that Milwaukee County addresses the needs and concerns of this population that deserves the very best.



DISTRICT 9 CONSTITUENT SERVICE

Ensuring that 9th District residents deserve prompt, responsive and professional constituent service, Supervisor Taylor hired a long-time Milwaukee County Board staffer Stefan Dostanic as his Legislative Assistant. Stefan graduated from Marquette University in 2007 with a degree in Political Science and History. His additional experience with politics includes working in Washington DC, with the Office of Congressman Ron Kind. He worked for former Supervisor Joseph A. Rice who retired from the County Board in April, 2012.

WHEATON FRANCISCAN HOSPITAL EXPANSION IN FRANKLIN


Based on recent growth and consumer demand, Wheaton Franciscan Healthcare proposes to construct a three-story, 64,800 square-foot Medical Office Building (MOB) on property it currently owns, north of Wheaton Franciscan Healthcare – Franklin at 10101 S. $27^{\rm th}$ St. The MOB and related improvements will be constructed on the southeast 14 acres of the 27-acre lot.

From emergency services to interventional diagnostics, surgery, ICU, inpatient care and now premiere physician office space, the Wheaton Franciscan Healthcare – Franklin campus will provide comprehensive healthcare in one convenient location close to home for Franklin residents.



The Franklin campus is also home to Midwest Orthopedic Specialty Hospital (MOSH), a 16-bed premiere hospital that is a leader in providing technologically advanced orthopedic procedures and quality patient outcomes with 24 board certified orthopedic surgeons on staff.

MOSH serves not just Franklin residents, but is recognized as a destination health facility in the Midwest and even internationally.
