Milwaukee County reforms have been the hot topic of discussion over the past few months. I campaigned on reform and looking at my votes on the Board floor I have followed through. I brought forward a downsizing plan and the Board approved a resolution asking the State to allow us to downsize and redistrict.

However, on Monday at the Intergovernmental Relations Committee I supported the Milwaukee County Board developed reform package. The very next day I read the Milwaukee Journal Sentinel story detailing what appears to most as negotiations with AFSCME, which is a clear violation of Act 10. As I previously stated, Act 10 is the law of the land and if members of the Board are willingly and knowingly violating this law then how can I honestly trust that they will follow through with the proposed Board reforms.

This is the first time in my 9 year political career that I can recall where in less than 24 hours after voting on an issue I felt that I made a mistake. Rarely in politics do you get a do over and I decided to take full advantage of this opportunity, reverse my decision and vote against the Board's reform proposal.

Due to what appears to have gone on behind closed doors over the past few months, my confidence in this body and its leadership has greatly eroded. That is why the only chance for real reform to take place in Milwaukee County is for it to occur in Madison.

I want to thank all of those who have reached out to me over the past few months in order to give me their insight and opinions. As I have said in the past, I cannot do this alone and without your support and encouragement we will not be able to Move Milwaukee County Forward.

Claim forms must be submitted to the Treasurer's Office.



# HALES CORNERS NAMED TREE CITY USA

The National Arbor Day Foundation once again named the Village of Hales Corners a Tree City USA to honor its commitment to community forestry. Hales Corners has received this recognition annually since 2001, having met the four standards to become a Tree City USA community: a tree board or department, a tree care ordinance, a comprehensive community forestry program, and an Arbor Day observance.

## MILWAUKEE COUNTY HOME REPAIR PROGRAM

The Milwaukee County Housing Division provides a home repair program using Federal Community Development Block Grants and HOME funds in communities excluding West Allis and the City of Milwaukee. The program offers low interest and 0% interest loans to income qualified homeowners for:

- **<u>Emergency Home Repair</u>**: Loans are made to restore basic functions to home including: water, hot water, heat, and municipal order compliance.
- **Standard Loan Programs:** Cover a wide range or repairs including: roofing, siding, trim, windows, porches, foundation repair, heating, plumbing, electrical or other necessary repairs.
